

Mr. Yoni Rendler (of New York) is married to Ms. Rochie Yarmush (of Montreal). The couple separated in 2015 and have one son. Mr. Yoni Rendler was summoned by the Beth Din of America to appear before them and refused to do so, resulting in a Siruv being issued by the Beth Din of America, on the 4th of February 2019 / 29 Shvat 5779.


Subsequently, this Beth Din has been involved in the case, and – since it is apparent that there is no further chance of reconciliation –has made many efforts to arrange a Get. Mr. Yoni Rendler has refused to do so.

Subsequent to the Siruv, the couple appeared in a New York court, and Rabbi Saul Emanuel, representing the Beth Din of Montreal, attended the hearing in New York, in the hope of trying to facilitate a settlement between the couple and to arrange a Get for Ms. Rochie Yarmush. Once again, Mr. Yoni Rendler refused to cooperate with regards to the Get. Any and all arrangements pertaining to custody of their son, are currently being handled by the New York courts and this issue cannot be used as an excuse for withholding the Get.

After many conversations, and many attempts, Mr. Yoni Rendler continues to refuse to give a Get to his wife, Ms. Rochie Yarmush. They have now been separated for over 5 years. We urge those who are able to convince Mr. Yoni Rendler to release his wife, Ms. Rochie Yarmush from this failed marriage and free her from her pain, to do so.
